1. Introduction of New Clerk

Cllr Reckless welcomed Gemma Smith to the meeting and informed the Council that she had been appointed to the position of Parish Council Clerk and Responsible Financial Officer on 12th June 2023. Training and handovers are underway.

A member of the public updated that the SID located on Westwood New Road was not working, it was noted that this had been recently serviced. The Chair suggested that the council should explore alternative equipment options due to the challenges face with regards to maintenance and cost of re-location.

Bonfire Event

A member of the public asked about ownership/organisational leadership of the Bonfire Event for 2023. It was noted that this had been reviewed and previously discussed by the Parish Council who are keen to maintain ownership of the event. It was recognised that the resource required to run the event would be significant and it was suggested that a collaborative approach with TCA would be beneficial. **Action: Parish Council to organise a scoping meeting for 29th June 2023. Feedback to TCA re collaboration and create a working group for the event.**

8. Allowing Members of the Public to speak outside of the Public Session and during the main Parish Council meeting as requested by Cllr Cocking


Tankersley Parish Council considered the request made by Cllr Cocking. It was noted that the request would differ from current Standing Orders and any changes would be inconsistent with the practice of other public bodies. It was RESOLVED that Standing Orders would not be changed and the council will continue to follow these.

12.3 **The Accounting Statements**


12.3.1 It was noted that the RFO had signed the Accounting Statements before presenting to the council.

 - ii) the Annual Governance Statement; and
 - iii) the Certificate of Exemption; and
- a statement that sets out—
 - iv) the period for the exercise of public rights;
 - v) details of the manner in which notice should be given of an intention to inspect the accounting records and other documents;
 - vi) the name and address of the local auditor;
 - vii) the provisions contained in section 25 (inspection of statements of accounts etc), section 26 (inspection of documents etc) and section 27 (right to make objections at audit) of the Act, as they have effect in relation to the authority in question;

12.4.4 Tankersley Parish Council authorised the RFO to submit documents and provide new clerk details.

13. **To Consider the Issues raised by Cllr Cocking Regarding Concerns Identified with the 2021-22 Audit**

Tankersley Parish Council reviewed and discussed Cllr Cocking concerns regarding failures to monitor the 2021-22 budget. It was noted that the former Clerk had raised these concerns with internal and external auditors as they were discovered. Actions has been taken to ensure that robust monitoring processes are in place for ongoing council business. It was RESOLVED that former Clerk took appropriate actions to address these issues and it was acknowledged that a retrospective 2021-22 budget creation would have been inappropriate and fraudulent.

14. **Asset Register**

14.1 Tankersley Parish Council reviewed and discussed Cllr Cocking request to change the format of the asset register.

14.2 Tankersley Parish Council RESOLVED that the Asset register format is prescribed by regulations 26(e) of the Transparency code and therefore would remain in its current format.

15. **Balancing the 2023/24 Budget**


It was RESOLVED to defer until 17th July 2020 Ordinary Meeting of Tankersley Parish Council.


