



Objective 4 isn't broad enough. I think this should include local amenities too (which they are currently none) such as shops, retail, other commerce and pubs. Within the scope we should be considering local food retailing, general retailing, salons, barbers, butchers, bakers, off licensing, bars, restaurants, cafes and takeaways - but broadly speaking and not specifically or overly prescriptively. Recommend the objective is amended as follows: Community facilities and amenities: -To explore and recommend how local community facilities and amenities can be developed, protected and enhanced to support current and future community needs for retail, social, leisure, sports and recreation activities.

I think the objectives cover what needs to happen in the village. One of the most important areas of focus should be walking and cycling facilities. The pavements in the area need particularly improving, especially on Lidgett Lane, which is used by lots of people walking but is virtually none existent! Perhaps there could also be some improvements made to the foot paths in the woods, which are also used by lots of people but are sometimes difficult to walk in. Perhaps there could also be some improvements made to footpaths through the local fields and the Wortley estate? The increase in housing has seen a significant increase in the amount of people walking (dogs or on their own!) and these are often used as walking routes but again the footpaths could be improved in these areas. The new road surface on New Road is a game changer!

Objective 6. Accessible Employment Local . Do we have more employment , we have the biggest eyesore in the county on our doorstep, EVRI and the majority of staff are "bused" in from Sheffield? Do they have a plan, a vision to work into our local schools and show their vision.? Objective 4. Community Facilitates . This village lacks a Pub, a place where one and all can convene and relax , please do not tell us the Welfare Hall covers this , a full time professional facility is required, entertainment , meals, not a cans out of a fridge and a facility run by volunteers or open to suit the weather? The opening hours can be dictated and there was no moaning when the Club / Gate was there previously but now there are objections to bringing one back , with almost double the numbers in the Parish??? 
There is nothing in the village for older people to access, as I am too old to drive, there are no facilities for us..I embraced the idea of the cafe etc. we need things for young people too.

As a resident of Westwood New Road directly opposite the school (St Peters) more housing = more terrible driving/parking behaviour. we already only have space for two "local cars" to park during school hours (for six properties) so I wouldn't want to see any more parking restrictions outside our houses. I know the safety of the children is very important, but there does have to be a balance for those of us who actually live here too. but I would like to see some protection for the grass verges which are getting damaged by inconsiderate parents/carers/teachers which spoils the look of the street for those of us who live here.

I would like to see a completely fresh set of objectives with input from people who are not over protective of the existing facilities and what they did in the 80's

I feel that grater aspects of the objectives needs to be explored. Such as transport links for public transport as there is only 1bus every 2 hrs. There are some facilities however these aren't in the village and people need to drive or walk to local shops aldi. The motorway junction has become much more busier and this is an impact on everyone. There has been new build estates however there is no 2-3 bedroomed houses which are more affordable for general public. Safety measures are needed for the village such as 20mph speed limits for the village.





2	Speeding in the village can be an issue. Consider traffic control measures. The current bus service may need improvement. I'm not sure on this one so maybe usage data gathered, and discussion held with providers.

4	Traffic around school is a problem. Traffic up to evri needs slowing down approaching school. I live on the Grange and parking issues at the school are an issue/dangerous.
5	Traffic getting worse, rabbit run from Motorway.
6	The village is often used as a rat run to avoid M1 Junction. The school parking needs to be addressed as a lot of times a fire engine could not get through. Put more double yellow lines around the school and along the road by the park!
7	My main concern is the single track road known as Pilley Lane. I speak from experience having travelled twice a day on it for the last 50 years (31200 times). It is no longer fit for the volume and type of traffic on it. Many dangerous incidents have been witnessed by me and the blind corners and width of the road could be improved by removing portions of the banking and relocating the pathway. Many times the pathway has been used by vehicles to pass.
8	Road traffic on the A61 especially Birdwell Roundabout are horrendous already and future development (housing or economic) will further eccacerbate this. Additional pollution. The Evri is an eyesore... why were they allowed to paint it blue? It hasn't delivered jobs for local people - no thought given to whether the local community would benefit in any way. People being bused in from out of area. Due to early / late shifts this has meant larger than normal use of the bus stops directly outside residential properties (eg Hoyland Common), with people talking and even sitting on walls of private property. Also, extra pedestrian footfall through the village to bus routes located outside village. Increase in litter. (not necessarily linked to pedestrians and could be linked to increased traffic). Roads in village, especially Lidgett Lane, not suitable for the volume of traffic using it.

Too much traffic. Lidgett Lane terrifies me. I'd love to be able to walk my children to school but can't take the risk. Its not wide enough, used as a rat run by inconsiderate drivers, and the speed! From Year 5 at Tankersley School, children are allowed leave school and walk home independently. Mine can't because it would involve Lidgett Lane. The school also encourage children to walk to school but we cannot do this due to safety concerns

I don't know if the transport issues listed at paragraph 35 are in priority order, but the traffic and parking at St Peters is indeed a major cause of frustration. The use of yellow lines (and hopefully support from Barnsley safer neighbourhood policing) should be used to move more, or all of, parental parking onto Westwood New Road which has more capacity for double parking without it becoming hazardous. The junction at the bottom of Lidgett Lane where it joins New Road is a fatal accident waiting to happen. At the very least, the exit from Lidgett should be a Stop rather than just a give way to allow for traffic infringement to be unequivocally prosecutable. It also needs speed bumps of the severest type to enforce cars approaching the junction at a sensible speed rather than the widespread 'starting grid' mentality that most drivers display. The amount of near misses that occur from drivers entering Lidgett from New Road without any considerations of the blind bend is horrendous. This could be resolved by making Lidgett a one way street, with entry only being from the Pilley Green end. 
